    - iii. Kathy Rizzuto also asked about AAU Team – this team is being coached by S. Musgrave and there are 8 out of 10 NEYSA players – Kathy questioned if we were using the NEYSA name. Anthony said no they are not using the NEYSA name. Just reviewed that if they need to use gym space they should be going through Chris Hanes to secure the space.

- b. Cheerleading (GM Danielle Heisey) – Not Present
- c. Competition Cheerleading (GM Shiann Barthel)
  - i. They are currently in between seasons
  - ii. July will start their new season and then competitions will start in October
- d. Soccer (GM Brent Shirk)
  - i. Spring season ended this past weekend
  - ii. Fall season is kicking into high gear – rosters send out
  - iii. Uniforms have been ordered
  - iv. Brent will email out expenditures (Plan of Operation)
    - 1. Brent will need to start purchasing more goals
